County aforesaid, near the Corporate limits of the City of Greenville, and having the following metes and bounds to wit: Beginning at an iron pin on the North-west corner of a lot belonging to the said Canton West and running S. 56-3/4 W. fifty (50) feet to an iron pin; thence S. 33-1/4 E. Sixty-one (61) feet to an iron pin; thence N. 56-3/4 E. fifty (50) feet to corner of lot belonging to said Canton West; thence N. 33-1/4 W. with line of said lot Sixty-one (61) feet to the beginning corner. being a portion of lot number 11, conveyed to me by D.D. Bailey, by his deed bearing date the 10th, day of September, 1907.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
