WARRANT OF ATTACH

TO ALL AND SINGULAR THE SHERIFFS AND CONSTABLES OF SAID STATE AND
COUNTY:

You are hereby commanded to attach and seize all the right,
title and interest of the Defendant, W. E. Connor, in and to the fol-
lowing-described property:

ALL That certain piece, parcel or lot of land,
in the county of Greenville, state of South
Carolina, situate, lying and being on the north-
ern side of Collinson Road, being known and desig-
nated as Lot No. 7 of Sylvan Hills Subdivision,
plat of which is recorded in the RMC Office for
Greenville County in Plat Book S at Page 103, said
lot fronting 70 feet on Collinson Road and having
such metes and bounds as shown on the plat refer-
enced to above, reference to said plat being made
for a more complete description. This being the
identical property conveyed to W. E. Connor by
deed of David Frank Atkins dated August 4, 1971,
recorded on the same date in the RMC Office for
Greenville County, S. C. in Deed Book 922 at Page
65.

ALL That piece, parcel or lot of land situate,
lying and being in the county of Greenville, shown
and designated on the Greenville County Tax Maps as
Lot 15, Block 1, Sheet 603.2, said property being
the old Sanoma School property; said Block Book ref-
erence is incorporated herein as a part of this mort-
gage and according to a survey by Piedmont Engineer-
ing Service, 1952, has the following metes and bounds,
to-wit:

BEGINNING At a point in the center of South Carolina
Highway No. 159, the point being one-half mile to Au-
gusta Road, and running thence with the center of said
highway, N. 77-15 E. 737.2 feet to an iron pin; thence
with Crymes' line, S. 12-45 E. 255.5 feet to a point;
thence continuing with line of Crymes' property, S. 78-
13 W. 639.3 feet to a point; thence N. 34-30 W. 264.0
feet to an iron pin in the center of said highway, the
beginning corner.
