Office for Greenville County, South Carolina, in Plat Book 4-R at pages 91 and 92, and having, according to said plat, the following metes and bounds:

BEGINNING at a point on the southern edge of Brockman Drive at the joint front corner of Lots 65 and 66 and running thence along a line of Lot No. 65, S. 06-48-32 W. 179.11 feet to a point; thence along lines of Lots 56 and 55, N. 87-49-32 E. 138.19 feet to a point; thence along a line of Lot 67, N. 01-39-31 E. 163.13 feet to a point on the southern edge of Brockman Drive; thence along the curve of the southern edge of Brockman Drive, the chord of which is N. 85-30-40 W. 121.9 feet to the beginning corner, and being a portion of the property conveyed by Mattie Brockman, et al., to Carolina Land Company, Inc. on December 20, 1972, and recorded on December 27, 1972, in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 963 at page 523.

This property is subject to existing easements, restrictions and rights of way upon or affecting said property.
