POWER OF ATTORNEY

and lawful Attorney-in-fact, to make, execute, seal and deliver for and on its behalf, and as its act and deed, bonds, undertakings, recognizances, contracts of indemnity, or other writings obligatory in the nature of a bond subject to the following limitation:

- 1. No one bond to exceed One Hundred Thousand Dollars (\$100,000.00).
- Bonds guaranteeing the performance and/or payment of labor and material bills on any type of construction project, including Supply Contract Bonds, are hereby expressly excluded.

and to bind the National Grange Mutual Insurance Company thereby as fully and to the same extent as if such instruments were signed by the duly authorized officers of the National Grange Mutual Insurance Company, and all the acts of said Attorney are hereby ratified and confirmed.
