That by virtue thereof, by the service and filing of this Notice and Certificate, and pursuant to the provisions of the Statutes in such cases made and provided, the undersigned has and claims a lien to secure the payment of the debt so due and the costs of enforcing said lien upon the buildings or structures herein above mentioned and upon the following described real estate:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Shawn Drive and being known as Lot No. 33 of a subdivision known as Rustic Estates, as shown by plat of Werber Co., Inc. by R. B. Bruce, Carolina Surveying Company dated August 13, 1980, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the southern side of Shawn Drive at the joint front corner of Lots Nos. 32 and 33 and running thence S. 42-01 W. 189.57- feet to a point; thence N. 42-19 W. 110-feet to a point on Waterloo Way; thence N. 37-04 E. 150-feet to a point at the intersection of Waterloo Way and Shawn Drive; thence with the intersection, N. 83-32 E. 34.42-feet to a point; thence along Shawn Drive S. 50-00 E. 99.60-feet to the point of beginning.
