33 E., 225.3 feet to an old iron pin at the southern edge of Rainbow Circle,
thence with Rainbow Circle S. 48-54 E., 98.2 feet to an iron pin, thence S.
72-32 E., 60 feet to an iron pin, thence N. 69-16 E., 50 feet to an iron pin,
