same for the purpose of defeating and defrauding plaintiff and plaintiff's interest therein and ownership thereof. Por the foregoing reasons, plaintiff is entitled to an attachment of all of said real property belonging to SIS under the provisions of Section 15-19-10, 1976 Code as security for the satisfaction of such judgments as plaintiff may recover against defendants in this action.

- 18. Plaintiff is entitled to an accounting of all of said monies and trust funds due it as hereinabove set forth.
- 19. Without an accounting from defendants, plaintiff is unable to determine the exact amount of the trust funds held by them, or under their control, and belonging to the plaintiff.

FOR A SECOND CAUSE OF ACTION

- 20. Plaintiff incorporates herein by reference all allegations of the Pirst Cause of Action as a part hereof except as modified hereinafter.
- 21. Heretofore on April 11, 1984, plaintiff (Company) and SIS (Agent) entered into an agreement entitled "General Agency Agreement" which is identical with the agreement set forth in paragraph 6 above except as to the date thereof and which appointed SIS as plaintiff's general agent for the State of Florida.
