- CLAIMS POLICY**
- All claims must be made within 30 days after receipt of merchandise.
 - Claims will be considered for manufacturing defects only.
 - Claims will not be considered for visible manufacturing defects or incorrect color after the carpet has been cut or installed.
 - Buyer and buyer's installers are responsible to make sure that style, size and color are correct before cutting and installing.
 - Claims for labor in connection with replacements will not be considered.
 - Claims will not be considered for carpet damaged through improper maintenance or improper installation.
 - Claims will not be considered for carpet sold as second quality, irregular, or remnants. All sales of this type are considered to be "As-is; No Warranty".
 - Color may vary slightly from dye lot to dye lot. Claims will not be considered for color variations within tolerances customarily considered acceptable in the carpet industry. Claims will not be considered for sidematch of different dye lots.
 - Claims for freight damage, visible or concealed are to be filed with the freight carrier. Bill of lading from the carrier acknowledges that they initially received the merchandise in good condition.
 - No merchandise may be returned unless authorized in writing. All claims are subject to final inspection by the manufacturer. Authorization for return of merchandise shall not be considered as a commitment to pay any claim. A 15% restocking fee plus freight will be charged to Buyer on any return which is found to have no manufacturing defect.
 - Claims will not be considered for consequential damages resulting from any delay or default in making delivery due to circumstances beyond Seller's control, including but not limited to, action of any governmental authority, shortages of labor, raw materials, production facilities, transportation, fires, floods, accidents, or any other commercial impracticability.
 - Backing or other raw materials may be changed without notice due to raw material shortages or when industry technological improvements become available to meet or exceed product performance.
 - In no case shall Seller's claims liability exceed the invoice price for the merchandise as shown on Seller's invoice to Buyer.
