

Beginning at a point along the southwestern edge of the right of way of Woodruff Road, joint corner of property now or formerly of South Carolina National Bank and running thence along the southwestern edge of the right of way of Woodruff Road S 65-19 E, 197.4 feet to a point along the center line of the right of way of Seaboard Coastline Railroad; thence running along the center line of Seaboard Coastline Railroad S 21-07 W, 269.5 feet to a point along the center line of Seaboard Coastline Railroad; thence continuing along the center line of the right of way of Seaboard Coastline Railroad the following courses and distances: S 21-07 W, 6.8 feet to a point; thence S 21-37-30 W, 99.5 feet to a point; thence S 26-32-30 W, 100.8 feet to a point, thence S 32-42-30 W, 101.0 feet to a point; thence S 38-40-30 W, 25.22 feet to a point along the center line of the right of way of Seaboard Coastline Railroad; thence leaving the line of right of way of Seaboard Coastline Railroad and running thence N 63-42-30 W, 122.42 feet to an iron pin along corner of property now or formerly of Southern Bell Telephone & Telegraph Co.; thence running along property now or formerly of Southern Bell Telephone & Telegraph Co. N 26-17-30 E, 200.0 feet to an iron pin; thence continuing along property now or formerly of Southern Bell Telephone & Telegraph Co. N 63-42-30 W, 260.8 feet to an iron pin along the southeastern edge of the right of way of Miller Road, thence running along the southeastern edge of the right of way of Miller Road N 23-36 E, 82.1 feet to an iron pin; thence continuing along the southeastern edge of the right of way of Miller Road N 22-42-30 E, 82.1 feet to an iron pin along the southeastern edge of the right of way of Miller Road; thence running property now or formerly of South Carolina National Bank S 65-36-30 E, 200.0 feet to an iron pin; thence continuing along property now or formerly of South Carolina National Bank N 20-58-30 E, 225.0 feet to an iron pin along the southwestern edge of the right of way of Woodruff Road, joint corner of property now or formerly of South Carolina National Bank, the point of beginning.
