note in writing, of even date with  
these presents, am well and truly indebted to City View Water and Sewer Commission  
Greenville, S.C. Three Hundred Seventy Five (\$375.00) Dollars  
in the full and just sum of  
to be paid: Five (\$5.00) Dollars per month beginning September  
1st, 1934  
with interest thereon from date 1934  
at the rate of 6 per cent. per annum, to be computed and paid  
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past  
due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose  
this mortgage; said note further providing for an attorney's fee of ten per cent  
besides all cost and expenses of collection, to be added to the amount due on the said note, and to be collectible as a part thereof; if the same be placed in the  
hands of an attorney for collection, or if said debt or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured  
under this mortgage); as to and by the said note, reference being hereunto had, will more fully appear.

according to the terms of said note, and also in consideration of the further sum  
of Three Dollars, to the said Louise C. Gower  
in hand well and truly paid by the said City View Water and Sewer Commission  
at and before the signing of these Presents, the receipt whereof  
is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said  
City View Water and Sewer Commission, its successors and  
assigns;

All that certain piece, parcel or lot of land situated, lying  
and being in Greenville Township, County and State aforesaid,  
on Bramlett Road in City View, known and designated as  
lot no. B, and having the following meters and bounds, to wit:  
Beginning at a stake on the north side of Bramlett Road,  
corner of lots A and B, and running thence with joint  
line of said lots in a northerly direction 134.9 feet to a stake  
on line of O'Neal property; thence in a westerly direction 65.1  
feet to a stake; thence in a southerly direction 140.5 feet to  
a stake on Bramlett Road; thence with Bramlett Road in an  
Easterly direction 52.9 feet to the beginning corner, said lot  
being shown on plat recorded in Plat Book "C" page 268,  
on which is situated a four room frame bungalow.
