bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Tryon Federal Savings & Loan Association all that piece, parcel or lots of land in Glassy Mountain Township, Greenville County, State of South Carolina, Lot # 100 BEGINAING at a point in the center bine of Hamilton Place at a distance 348.0 feet more or less from it's eastern intersection with the Clark Place Road, said beginning point being located exactly 39.5 feet eastward from the beginning of a circular curve at the right described by said center line with a radius of 183.0 feet, said beginning of curve being duly referenced by two concrete monuments as shown of aforesaid plat, and running thence along the line drawn at an angle of 85 deg. and 32 min. to the right from said center line a distance of 143.0 feet northward more or less to the extreme corner of Lot #106, thence along a line perpendicular to the last described line northwestward a distance of 50.0 feet to the extreme western point of Lot 106, thence along a line parallel to the first described line to an intersection with the center li line of said Hamilton Place a distance of 140.0 feet more or less, thence southward along the center line of said Hamilton Place, to the beginning a distance of 50.0 feet saving and accepting a strip of land adjacent to the center line of Hamilton Place, bounded by a line to the south of parallel to and 15.0 feet distance from the center line of said road, which strip of land is reserved for use by the public as a street, and be it understood that all distances described as curved lines are to be measured inchords of 25.0 feet of fractional parts, and that the said lot has a width at the building line of 50.0 feet.
