WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seventeen Hundred and No/100- - - - - DOLLARS (\$ 1700.00 ), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Northern side of Tremont Avenue, near the City of Greenville, being shown as Lot No. 19 of Block C on Plat of Melrose Land Company, recorded in Plat Book A at Page 157, and having a frontage of 50 feet on the Northern side of Tremont Avenue, with a uniform depth of 140 feet, and being 50 feet across the rear."

Being the same property conveyed to Clarence W. Petty and Ruby M. Petty by Church of God by deed recorded in Book of Deeds 265 at Page 99, and the said Ruby M. Petty having conveyed her interest to Louise K. Petty by deed recorded herewith.
