Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

organized and existing under the laws of **South Carolina**, a corporation
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of **Twenty-nine Hundred Fifty -**

if not sooner paid, shall be due and payable on the first day of **March**, 19 **69**.

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of **Greenville**,
State of South Carolina:

All that piece, parcel or lot of land with the improvements thereon situate,
lying and being in **Dunean Mills Village, Greenville County, South Carolina**, and
being more particularly described as **Lot No. 47, Section 2**, as shown on a plat

Pickell, Engineers, Greenville, S. C., on **June 7, 1948**, revised **June 15, 1948**, and
