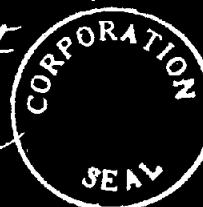
This mortgage is given to secure a portion of the purchase price of the within described property and includes jacket water heater and tank installed in said premises.
