WHEREAS, the Mortgagor is well and truly indebted unto

All that piece, parcel or lot of land with the improvements thereon situate lying and being in **Duncan Mills Village, Greenville County, South Carolina**, and being more particularly described as Lot No. **47**, Section **1**, as shown on a plat entitled "Subdivision for Duncan Mills, Greenville, S. C.", made by **Pickell & Pickell, Engineers, Greenville, S. C.**, on June 7, 1948, revised June 15, 1948, and August 7, 1948, and recorded in the R. M. C.
