TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, Lee Finley and Eula Finley (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto W.B.McDowell

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

---SIX HUNDRED and No/100 -----DOLLARS (\$ 600.00 ),

with interest thereon from date at the rate of six per centum per annum, said principal and interest to be repaid: Twenty Five (\$25.00) Dollars on April 15th. 1949, and a like payment of \$25.00 on the 15th. day of each successive month until paid in full. Said payments to be first applied to interest, balance to principal.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Bruce street in the City of Greenville, and being shown and designated as lot No. 8 on plat of the property of W.B.McDowell, recorded in the R.M.C. office for Greenville County in Plat Book "S" at page 53, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Bruce street at the joint front corner of lots 8 and 9, and running thence with the line of lot No. 9 S.8-15 E. 133.2 feet to an iron pin at corner of lot No. 2.; thence with the rear line of lot No. 2 N. 68-19 E. 58.2 feet to iron pin at corner of lot No. 7 ; thence with line of lot No. 7. N.8-15 W. 126.5 feet to an iron pin on Bruce street; thence with the Southern side of Bruce street S.74-30 W.57 feet to the point of beginning.

Said lot being the same this date conveyed to the mortgagors by W.B.McDowell, by deed to be recorded herewith, and this mortgage is given to secure the unpaid portion of the purchase price.
