C.", made by Pickell & Pickell, Engineers, Greenville, S. C., on June 7, 1948, revised June 15, 1948, and August 7, 1948, and recorded in the R. M. C. According to said plat the within described lot is also known as No. 814 Smythe Street (Avenue) and fronts thereon 206.7 feet.
