TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, **Will F. Jameson and Carrie G. Jameson** (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **W. B. McDowell**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Two Hundred Eighty and No/100**

DOLLARS (\$280.00),

with interest thereon from date at the rate of **six** per centum per annum, said principal and interest to be repaid: **\$15.00 on the 29th day of May, 1949, and a like payment of \$15.00 on the 29th day of each and every month thereafter until paid in full. Said interest is from date at the rate of six per cent and is to be payable annually.**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **in Greenville Township, in the City of Greenville, being known and designated as lot No. 19 on Plat of Property of W. B. McDowell, recorded in the R.M.C. Office for Greenville County in Plat Book 8 at Page 53, and having, according to said Plat, the following metes and bounds, to-wit:**

"BEGINNING at an iron pin on the Eastern side of Chestnut Street, at the joint front corner of lots Nos. 17 and 19, and running thence with the line of lot No. 17, N. 81-45 E. 212.6 feet to an iron pin; thence N. 13 W. 50.1 feet to iron pin, corner of lot No. 21; thence with the line of lot No. 21, S. 81-45 W. 207.6 feet to an iron pin on Chestnut Street; thence with the Eastern side of Chestnut Street, S. 8-15 E. 50 feet to the point of beginning."

Being the same premises conveyed to the mortgagors by W. B. McDowell by deed to be recorded.
