WHEREAS, the Mortgagor is well and truly indebted unto

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Fifty-nine Hundred Fifty - Dollars (\$ 5950.00)**, with interest from date at the rate of **four and one-half per centum (4½ %)** per annum until paid, said principal and interest being payable at the office of **C. Douglas Wilson & Co.** in **Greenville, S. All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the South side of **Pleasant Ridge Avenue**, in that area recently annexed to the City of **Greenville**, in **Greenville County**, South Carolina, being shown as **Lot #129** on **Plat of Pleasant Valley, Section 1**, made by **Dalton & Neves, Engineers**, April 1946, recorded in **R. M. C. Office** for **Greenville County, S. C.** in **Plat Book P**, page 93, said lot fronting 60 feet on the South side of **Pleasant Ridge Avenue**, with a depth of 160 feet on the East side, a depth of 160 feet on the West side, and being 60 feet across the rear.
