, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Forty-eight Hundred & No/100 Dollars (\$4800.00), with interest from date at the rate of four and one-half per centum (4 1/2 %) per annum until paid, said principal and interest being payable at the office of C. Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the West side of Tomassee Avenue, in that area recently annexed to the City of Greenville, in Greenville County, S. C., being shown as the Northern 23 feet of Lot 77 and the Southern 34 feet of Lot 78 adjacent thereto on Plat of Augusta Circle, made by R. E. Dalton, Engineer, November 1921, recorded in R. M. C. Office for Greenville County, S. C. in Plat Book F, pages 22 and 23, said lot fronting 57 feet on the West side of Tomassee Avenue, with a depth of 150 feet on the North side, a depth of 150 feet on the South side, and being 57 feet across the rear.
