To All Whom These Presents May Concern

Ernest Davis Campbell

hereinafter spoken of as the Mortgagor send greeting.

Whereas Ernest Davis Campbell

is justly indebted to C. Douglas-Wilson & Co., a corporation organized and existing under the laws of the State of South Carolina, hereinafter spoken of as the Mortgagee, in the sum of Thirteen Hundred and No/100 - - - - - Dollars

(\$ 1300.00), lawful money of the United States which shall be legal tender in payment of all debts and dues, public and private, at the time of payment, secured to be paid by that one certain bond or obligation, bearing even date herewith, conditioned for payment at the principal office of the said C. Douglas Wilson & Co., in the City of Greenville, S. C., or at such other place either within or without the State of South Carolina, as the owner of this obligation may from time to time designate, of the sum of Thirteen Hundred and No/100 - - - - - Dollars (\$ 1300.00)

with interest thereon from the date hereof at the rate of four per centum per annum, said interest to be paid on the first day of October 19 49 and thereafter said interest and principal sum to be paid in installments as follows: Beginning on the first day of November 1949, and on the first day of each month thereafter the sum of \$ 9.62 to be applied on the interest and principal of said note, said payments to continue up to and including the first day of September, 19 64 and the balance of said principal sum to be due and payable on the first day of October, 19 64; the aforesaid monthly payments of \$ 9.62 each are to be applied first to interest at the rate

of four per centum per annum on the principal sum of \$ 1300.00 or so much thereof as shall from time to time remain unpaid and the balance of each monthly payment shall be applied on account of principal. Said principal and interest to be paid at the par of exchange and net to the obligee, it being thereby expressly agreed that the whole of the said principal sum shall become due after default in the payment of interest, taxes, assessments, water rate or insurance, as hereinafter provided.

Now, Know All Men, that the said Mortgagor in consideration of the said debt and sum of money mentioned in the condition of the said bond and for the better securing the payment of the said sum of money mentioned in the condition of the said bond, with the interest thereon, and also for and in consideration of the sum of One Dollar in hand paid by the said Mortgagee, the receipt whereof is hereby acknowledged, has granted, bargained, sold, conveyed and released and by these presents does grant, bargain, sell convey and release unto the said Mortgagee and to its successors, legal representatives and assigns forever, all that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being on the West side of Tomassee Avenue, in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as the Northern 23 feet of Lot 77 and the Southern 34 feet of Lot 78 adjacent thereto on a plat of Augusta Dipole, made by R. E. Dalton, Engineer, November 1921, recorded in R.E.C. Office for Greenville County, S. C. in Plat Book F, pages 22 and 23, said lot fronting 57 feet on the West side of Tomassee Avenue, with a depth of 150 feet on the North side, a depth of 150 feet on the South side, and being 57 feet across the rear.

This mortgage is subordinate to a certain mortgage made by Ernest Davis Campbell to C. Douglas Wilson & Co., dated September 7, 1949, originally in the amount of \$4800.00 and filed in the R. E. C. Office for Greenville County, State of South Carolina on September 7, 1949.

The parties hereto agree that any default under the prior mortgage shall constitute a default hereunder.
