Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to

organized and existing under the laws of the State of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Sixty-one Hundred, Fifty and no/100

Dollars (\$ 6,150.00), with interest from date at the rate of four per centum (4 %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co.

in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Thirty-two and 47/100

Dollars (\$ 32.47), commencing on the first day of November, 19 49, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of October, 19 74.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, Santt Township, State of South Carolina; being known and designated as Lot No. 226, according to plat of Section A of the property of Woodfields, Inc., a subdivision located on the southwest side of the Augusta Road, which plat was made by the Piedmont Engineering Service on August 23, 1948 and which plat is recorded in the R. M. C. Office for Greenville County, in Plat Book W, at page 75 and having, according to said plat, the following metes and bounds, to wit:

Beginning at an iron pin on the northwestern side of Fox Hall Road at the joint front corner of Lots Nos. 225 and 226 and running thence along the line of Lot No. 225 N. 60-42 W. 188.1 feet to an iron pin at the rear corner of Lot No. 225; thence S. 89-15 W. 75 feet to an iron pin at the rear corner of Lot No. 226; thence along the line of Lot No. 227 S. 60-42 W. 182.2 feet to an iron pin on Fox Hall Road; thence along Fox Hall Road E. 28-44 E. 78.0 feet to the point of beginning.
