Greenville Township, Greenville County, State of South Carolina.

All that lot fronting on North Main Street in the City of Greenville, South Carolina, which is shown on a Plat of Highland Terrace, development Hindman, addition to Greenville, South Carolina, dated October 1936, Plated by W. J. Riddle, and is recorded in Plat Book 3 at pages 120-122, as Block "A", rear portion of lots one and two, including the alley, and from this Plat the following description is taken:

BEGINNING at a point in the eastern line of Lot one which is the joint corner between the lot herein conveyed and lot heretofore conveyed to Dorothy Hindman Davenport, which point is 118.2' from the South-western intersection of Hillcrest Drive and North Main Street and running thence along the line of Dorothy Hindman Davenport across lots one and two to a point in the joint line between lots two and three, which point is the joint rear corner between the lot herein conveyed and the lot of Dorothy Hindman Davenport and is 118' from the Southern edge of Hillcrest Drive; and running thence along the joint line between lots two and three S. 23-30 W. across a 15' alley to a point in the southern side of said alley and a total distance of 87' more or less; thence along the Southern side of said alley S. 66-30 E. to a point on the Western side of Main street, a distance of 167' more or less; thence N. 19-47 E. across said alley and along the Eastern line of Lot one to the beginning point, which is the joint corner of Dorothy Hindman Davenport, a dis-
