MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Allan Robinson (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto T. H. Fowler

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Hundred and No/100- - -

DOLLARS (\$ 700.00),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: One year after date, with interest thereon from date at the rate of Six per cent, per annum, to be computed and paid semi-annually

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gannt Township, being known and designated as part of Tract No. 5 in the subdivision of the lands of C.A. Satterfield deceased, recorded in Plat Book "T" at page 89, containing 11.84 acres, more or less, and having the following courses and distances:

BEGINNING in or near the center of a road, joint corner of tracts, 1, 2, 4 and 5 and running thence along the northeastern side of tract 4, N.54-25 W. 32.45 chs. to an oak; thence along the line of the Garrison land S.71.30 E.28.08 chs. to corner of four acre tract shown on said plat; thence along the western boundary of said tract S.17-00 W. 6.34 chs. ; thence along the southern boundary of said tract S.71-30 E. 6.34 chs to point in or near said road; thence along the center of said road S.23.40 W. 3.80 chs. to the beginning corner. Said premises being the same this date conveyed to the mortgagor by Sarah S. Wilson, and this mortgage is given to secure a portion of the purchase price thereof.
