I, J. H. Mauldin (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All ~~the~~ certain pieces parcels or lots of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Butler Township on the Northeastern side of Laurens Road, in the City of Greenville, being shown and designated as Lots Nos. 210, 211 and 212 of East Lynn Addition, recorded in Plat Book H at Page 220, and when described together, have the following metes and bounds according to said Plat:

"BEGINNING at an iron pin on the Northeastern side of Laurens Road at joint front corner of Lots Nos. 212 and 213, and running thence with the line of Lot No. 213, N. 20-24 W. 239.4 feet to iron pin in line of Lot No. 209; thence with the line of Lot No. 209, S. 68-28 W. 138 feet to iron pin; thence S. 14-32 W. 294.6 feet to iron pin on Laurens Road; thence with the Northeastern side of Laurens Road, N. 52-28 W. 60.7 feet to pin; thence continuing N. 52-07 W. 60 feet to pin; thence continuing with Laurens Road, N. 49-48 W. 60 feet to the beginning corner."
