TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, Bruce Thomas and Anabel Lupo Thomas  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Five Hundred and No/100- - - - - DOLLARS (\$2500.00), with interest thereon from date at the rate of Six (6%) - - - per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, partially in School District 8G and partially in School District 8GD, and being shown on the County Block Book as lot No. 22, Block 1, Sheet 211, and being more particularly described as follows:

"BEGINNING at a point on the East side of the Old Augusta Road at the North-west corner of property now or formerly owned by B. F. Griffith, and running thence with Griffith line in an Easterly direction 110 feet to a point; thence in a North-erly direction in a line parallel with the Old Augusta Road, 50 feet to a point; thence along line of property owned by W. R. Lupo in a westerly direction and parallel to the Griffith line 110 feet to a point on the East side of the Old Augusta Road; thence with the East side of said road in a Southerly direction 50 feet to the be-ginning corner."

Being the same premises conveyed to the mortgagors by W. R. Lupo by deed recorded in Volume 400 at Page 215.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same be-longing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it be-ing the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
