porated herein by reference, in the principal sum of Sixty-four Hundred and no/100
Dollars (\$ 6400.00), with interest from date at the rate of
four per centum (4 %) per annum until paid, said principal and interest being payable
at the office of C. Douglas Wilson & Co.
in Greenville, or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of Thirty-three and
79/100 Dollars (\$ 33.79), commencing on the first day of
March, 19 50 and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the first day of February, 19 75.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of Greenville
State of South Carolina; Greenville Township, being known and designated as
Lot No. 149, according to a plat of property of Sans Souci Housing,
Inc., plat made by Piedmont Engineering Service on January 16, 1950,
and recorded in the R.M.C. Office for Greenville County in Plat
Book X at Page 61, and having according to said plat the following
metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Decatur Street
at the joint front corner of Lot Nos. 148 and 149 and running thence
along the line of Lot No. 148 N. 57-00 W. 150 feet to iron pin on
a 15 foot alley; thence along the southern side of said alley
N. 39-18 E. 66 feet to an iron pin at the rear corner of Lot No. 150;
thence along the line of Lot No. 150 S. 57-00 E. 150 feet to an iron
pin on Decatur Street; thence along Decatur Street S. 39-17 W. 66
