USL—First Mortgage on Real Estate

TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, W. H. Forrest and Gladys M. Forrest

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Two Thousand and No/100-** - - - - -
DOLLARS (\$ 2000.00), with interest thereon from date at the rate of **Five (5%)** - - per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, in the area recently annexed to the City of Greenville, being known and designated as a part of lot No. 20 of a Subdivision known as Croft Stone Acres, as shown on plat thereof made by W.D. Neves, Eng., and recorded in Plat Book E, at Pages 35 and 36, and being more particularly described as follows:

"BEGINNING at an iron pin on the North side of Wedgewood Avenue, at a point 73 feet West of the joint corner of lots Nos. 19 and 20, being the corner of the McCain lot, and running thence along the line of the McCain lot, N. 33-35 W. 200 feet to pin at rear of McCain lot; thence in a Northwesterly direction 37 feet to iron pin in middle of branch; thence along middle of branch 75 feet to stake in middle of branch; thence in a southeasterly direction 14 feet to iron pin; thence S. 33-35 E. 200 feet to pin on Wedgewood Avenue; thence along the North side of Wedgewood Avenue, N. 51-45 E. 65 feet to point of beginning."

Said premises being the same conveyed to mortgagors by Alva H. Lowe and Bessie O. Lowe by deed to be recorded.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
