SEND GREETING:

Whereas, I, the said C. K. Campbell

with interest thereon from date

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who

Road, adjoining lands of the estate of Hugh Baldwin, lands of Mrs. Miller  
W. J. Greer and others - Beginning at an iron pin on the north side of  
a side road leading west from the Old Greenville-Laurens Stage Road and  
running thence along the west side of the side road to residence of D.  
L. Luquire S. 7 3/4 E. 4.78 to iron pin on ditch near residence; thence
