MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Charles Wriston Scales, Jr. (same as Charles W. Scales, Jr.) SEND GREETING:
WHEREAS, I, the said Charles Wriston Scales, Jr.

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of TEN THOUSAND AND NO/100 (\$10,000.00) four (4%)

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of.....

SIXTY AND NO/100 (\$60.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I, the said Charles Wriston Scales, Jr.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me, the said.....

Charles Wriston Scales, Jr. in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, School District 8-G, now a part of the City of Greenville, and being known and designated as the greater portion of Lot No. 25 and a small portion of Lot No. 24 of a subdivision known as Forest Heights, as shown on plat thereof made by Dalton and Reves in June, 1946 and recorded in the R. M. C. office for Greenville County in Plat Book P, at page 71, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southwest side of Longview Terrace at the corner of Lot No. 26, and running thence along the Southwest side of Longview Terrace, S. 68-37 E. 70 feet to an iron pin at the corner of Lot No. 24; thence still along the Southwest side of Longview Terrace, S. 69-16 E. 2 feet to an iron pin; thence in a Southwesterly direction, intersecting the joint line of Lots Nos. 24 and 25 about midway, 143 feet, more or less, to an iron pin in the center of a 10-foot strip reserved for utilities, which point is 2 feet northwest of the rear corner of Lots Nos. 24 and 25; thence along the center of said strip reserved for utilities, N. 65-45 W. 68.1 feet to an iron pin at the rear corner of Lot No. 26; thence along the line of that lot, N. 20-44 E. 139.7 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the greater portion of the lot conveyed to me by Algie C. Poole by deed dated October 21, 1949, recorded in the R. M. C. office for Greenville County
