TO ALL WHOM THESE PRESENTS MAY CONCERN:

PAULINE W. WARD SEND GREETING:  
WHEREAS, I the said Pauline W. Ward,

in and by ME certain promissory note in writing, of even date with these Presents am well and truly indebted to the LIBERTY LIFE INSURANCE COMPANY, a corporation chartered under the laws of the State of South Carolina, in the full and just sum of Eleven Thousand Five hundred & no/100 - - - (\$ 11,500.00) DOLLARS, to be paid at its Home Office in Greenville, S. C., together with interest thereon from date hereof until maturity at the rate of five ( 5 %) per centum per annum, said principal and interest being payable in monthly instalments as follows:  
Beginning on the 30th day of June, 1950, and on the 30th day of each month of each year thereafter the sum of \$ 145.59 to be applied on the interest and principal of said note, said payments to continue up to and including the 30th day of April, 1958, and the balance of said principal and interest to be due and payable on the 30th day of MAY, 1958; the aforesaid monthly payments of \$ 145.59 each are to be applied first to interest at the rate of five ( 5 %) per centum per annum on the principal sum of \$ 11,500.00 or so much thereof as shall, from time to time, remain unpaid and the balance of each monthly payment shall be applied on account of principal.

All instalments of principal and all interest are payable in lawful money of the United States of America; and in the event default is made in the payment of any instalment or instalments, or any part thereof, as therein provided, the same shall bear simple interest from the date of such default until paid at the rate of seven (7%) per centum per annum.

And if at any time any portion of principal or interest shall be past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole sum of the principal of said note remaining at that time unpaid together with the accrued interest, shall become immediately due and payable, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and if said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings; then and in either of such cases the mortgagor promises to pay all costs and expenses including a reasonable attorney's fee, these to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Ward in hand well and truly paid by the said LIBERTY LIFE INSURANCE COMPANY, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said LIBERTY LIFE INSURANCE COMPANY, its Successors and Assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the South side of Club Drive in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as Lot 61 on plat of Property of Geer and Anderson made by R. E. Dalton, Engineer, March 1923, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book B, page 165 (see also plat Ables & Rasor Property recorded in Plat Book E, page 153) and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Club Drive at joint front corner of Lots 61 and 62, and running thence along the South side of Club Drive, N. 65-30 E. 80.06 feet to an iron pin at corner of Lot 60; thence with the line of Lot 60, S. 19-26 E. 167.5 feet to an iron pin; thence S. 66-26 W. 82 feet to an iron pin at the rear corner of Lot 62; thence along the line of Lot 62, N. 18-44 W. 166.3 feet to the beginning corner.
