(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Fifty-Three Hundred and No/100- - - - -** DOLLARS (\$ 5300.00), with interest thereon from date at the rate of **Five (5%)**- - - per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, on the Northern side of Orders Drive, being known and designated as lot No. 46, on plat of Orderest Park, recorded in Plat Book S at Page 109, and described as follows:

"BEGINNING at an iron pin on the Northern side of Orders Drive, at the joint front corner of lots 46 and 45, and running thence with line of lot No. 45, N. 7-58 W. 163.4 feet to an iron pin; thence N. 81-44 E. 60 feet to an iron pin at rear corner of lot No. 47; thence with line of lot 47, S. 9-24 E. 163.2 feet to an iron pin on Orders Drive; thence with the Northern side of Orders Drive, S. 81-53 W. 65 feet to the point of beginning."
