DOLLARS (\$ 550.00 ),

with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid: Six months after date.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, Laurel Creek School District, near the Laurens Road, on the West side of Sycamore Drive, and designated as Lot No. 110 on Plat of East Lynne Addition, made by Dalton & Neves in May 1933, recorded in Plat Book H at Page 220, and described as follows:

"BEGINNING at a point on the West side of Sycamore Drive, joint corner of Lots Nos. 110 and 111, thence S. 28-35 W. 202.7 feet to point on line now or formerly of Zora Ridgeway; thence with her line, N. 64-41 W. 50 feet to the joint rear corner of Lots Nos. 109 and 110; thence along the line of said 2 lots, N. 28-35 E. 206 feet to iron pin on the West side of Sycamore Drive; thence with the West side of Sycamore Drive, S. 61-10 E. 50 feet to the beginning corner."
