SENDS GREETING:

Whereas, I, the said E. B. Willis, Jr., hereinafter called the mortgagor(s) in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to The Peoples National Bank of Greenville, S. C., hereinafter called the mortgagee(s), in the full and just sum of Thirty-five Hundred & no/100 - - - DOLLARS (\$ 3,500.00), to be paid four (4) months after date,

, with interest thereon from date at the rate of five (5%) percentum per annum, to be computed and paid at maturity until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor(s) promise to pay all costs and expenses including 10 per cent. of the indebtedness at attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That I, the said mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee(s) according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said mortgagor(s), in hand well and truly paid by the said mortgagee(s) at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said The Peoples National Bank of Greenville, S. C., its successors and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being on the Western side of West Decatur Street near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 80 on plat of Property of J. P. Rosamond, made by Dalton & Neves, Engineers April 1931, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book H, at page 186, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the Western side of West Decatur Street which is the joint front corner of Lots 80 and 81, and running thence their joint line N. 83-45 W. 175.6 feet to their joint rear corner; thence the rear line of Lot 80, 62.8 feet to the joint rear corner of Lots 79 and 80; thence the joint line between these lots, S. 83-45 E. 157 feet to their joint front corner on West Decatur Street; thence along the Western edge of said street, N. 6-15 E. 60 feet to the beginning corner.
