, to be paid \$28.31 on the 25th day of December 1950, and \$28.31 on the 25th day of each and every month thereafter until the full amount of principal and interest has been paid. From each monthly payment interest shall be first paid and the balance credited as a principal reduction.

, with interest thereon from date

at the rate of five per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear

Hagood, deceased, its Successors and Assigns, all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the West side of Textile Avenue in the Town of West Greenville (now in the City of Greenville), being known and designated as part of lots Nos. 15 and 16, Block "D", on Plat of Melville Land Company No.2 prepared by Lockwood, Greene & Company, May 1905, which Plat is recorded in the RMC Office for Greenville County in Plat Book "A", page 97, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at the corner of lot conveyed to E. M. Galphin by W. L.
