To All Whom These Presents May Concern:

Dollars, with interest at the rate of ~~six (6%)~~ four (4%) per centum per annum, to be repaid in instalments of.....

Twenty-Seven and 27/100 (\$ 27.27) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of .. Greenville, and in Butler Township, School District 7-H, being known and designated as Lot No. 10, Block H, of a subdivision known as "Fair Heights" according to a survey and plat of the same prepared by R. E. Dalton, Engineer, October, 1924, recorded in the R. M. C. office for Greenville County in Plat Book F, page 257, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southwest side of Brookdale avenue at the joint front corner of Lots Nos. 10 and 11, said pin being 100 feet from the northwest corner of the intersection of Brookdale avenue and Hanover street, and running thence along the joint line of said Lots Nos. 10 and 11, N. 58-40 W. 150 feet to the joint rear corner of Lots Nos. 14 and 15; thence along the rear line of Lot No. 15, N. 31-20 E. 50 feet to an iron pin at the joint rear corner of Lots Nos. 15 and 16; thence along the joint line of Lots Nos. 9 and 10, S. 58-40 E. 150 feet to a pin on the southwest side of Brookdale Avenue; thence along the southwest side of Brookdale Avenue, S. 31-20 W. 50 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
