OLLIE FARNSWORTH R.M.C. MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Carl B. Holland

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Joe H. Long

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Eleven Hundred Seventy and No/100**

DOLLARS (\$ 1170.00),

with interest thereon from date at the rate of **Five** per centum per annum, said principal and interest to be repaid: **Six months after date, with interest thereon from date at the rate of Five (5%) per cent, per annum, to be computed and paid semi-annually.**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the **Northeastern side of Keith Street, in the City of Greenville, being shown as lots Nos. 43 and 46 on plat of property of Ed B. Smith, made by Pickell & Pickell on January 15, 1945, recorded in Plat Book S at Page 23, and described as follows:**

LOT 46: "BEGINNING at a stake on the Northeastern side of Keith Street, 333 feet Northwest from Clay Street, at corner of lot 47, and running thence with the line of said lot, N. 54-15 E. 150 feet to a stake; thence N. 35-45 W. 75 feet to a stake at corner of lot 45; thence with the line of said lot, S. 54-15 W. 150 feet to a stake on Keith Street; thence with Northeastern side of said Street, S. 35-45 E. 75 feet to beginning."

LOT 43: "BEGINNING at a stake on the Northeast side of Keith Street, 558 feet Northwest from Clay Street, at corner of lot 44, and running thence with the line of said lot, N. 54-15 E. 150 feet to a stake; thence N. 35-45 W. 75 feet to a stake at corner of lot 41; thence with the line of said lot, S. 54-15 W. 150 feet to a stake on Keith Street; thence with the Northeastern side of said Street, S. 35-45 E. 75 feet to the beginning corner."

Being the same property conveyed to the mortgagor by Ed B. Smith by deed to be recorded herewith.

This mortgage is given to secure the unpaid portion of the purchase price.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
