SEND GREETING:

Whereas, I, the said **Leo H. Collins Jr**  
in and by my certain **promissory** note in writing, of even date with these  
Presents, **am** well and truly indebted to **B.F. Flynn Estate**  
in the full and just sum of **Five Hundred Fifty Dollars**  
, to be paid **as herein stated**

, with interest thereon from **date**  
at the rate of **six** per centum per annum, to be computed and paid **annually**

until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to  
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

**its heirs and assigns forever.**

County, State of South Carolina, and having the following metes and bounds  
to wit;  
BEGINNING at an iron pin on the North side of Highland Street, at the S.E.  
corner, of lot No 27, and runs thence N. 77.35 E. 200 feet along said Highland  
Street to a stake: thence N. 9.11 E. 204 feet along line of lot No 32, to a  
stake; thence S. 67.15 W. along line of lots Nos. 3, 4, 5, and 6 to a stake:
