TO ALL WHOM THESE PRESENTS MAY CONCERN: I, W.L. Bruce, Sr.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Three Hundred Fifty & No/100-----
DOLLARS (\$ 350.00), with interest thereon from date at the rate of Six (6%)
per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs

Township, in the City of Greer, on the West Side of South Line Street, and having the following courses and distances, to wit:-

Beginning at a point on branch and runs thence N. 87 1/2 E. 2.54 chains to an iron pin on Line Street; thence along said street N. 1 1/2 E. 1.37 1/2 chains to an iron pin in line of G.R. Fowler lot; thence with his line 2.76 chains to iron pin in branch; thence down said branch 1.65 chains to the beginning.

This is the same land conveyed to W.L. Bruce by deed from J.G. Westmoreland as Executor of the will of Mrs. L.E. Westmoreland, deed dated December 6th, 1933, and recorded in the R.M.C. Office in and for Greenville County in Vol. 171 at page 468.
