TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, C. H. Wike

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Two Hundred and No/100- - - - - DOLLARS (\$ 2200.00), with interest thereon from date at the rate of Six (6%) - - per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being shown as part of lots Nos. 115 and 116, on plat of City View, recorded in Plat Book A at Pages 460 and 461, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at a stake on the corner of Summitt Street and Hunt Street and running thence with Hunt Street, N. 10 E. 110 feet to a stake, joint corner of lots 116 and 117, thence with the joint line of said lots in an easterly direction to a stake in corner of lot heretofore conveyed to C. L. Phillips; thence with line of said lot in a southerly direction 102 feet, more or less, to a stake on Summitt Street; thence with Summitt Street, N. 80-30 W. 90 feet more or less, to beginning corner."
