I, Fred R. Cobb

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three Thousand and No/100- - - - - DOLLARS (\$ 3000.00 ), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southwest side of Bates Street, being known and designated as lot 9, as shown on plat of property of H. B. Bates, recorded in Plat Book F at Page 32, being more particularly described as follows:

"BEGINNING at an iron pin on the Southwest side of Bates Street, at corner of lot 7, which point is 277 feet from the intersection of Anderson Road and Bates Street, and running thence along line of lot 7, S. 48-30 W. 150 feet to iron pin; thence N. 55-40 W. 50 feet to an iron pin, joint rear corner of lots 9 and 11; thence with joint line of said lots, N. 48-30 E. 150 feet to an iron pin on the Southwest side of Bates Street; thence with said Street, S. 55-40 E. 50 feet to the point of beginning."
