TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Leland W. Kelley

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifty-Five Hundred and No/100- - - - - DOLLARS (\$ 5500.00), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Whitehall Street, in the City of Greenville, being the rear portion of lot No. 6 of Section B as shown on plat of Stone Land Company recorded in Plat Book A at Page 336, and described as follows:

"BEGINNING at an iron pin on the Western side of Whitehall Street, 135 feet North from Croft Street, and running thence with the Western side of Whitehall Street, N. 1-41 E. 65 feet to a stake at corner of the 16 foot alley; thence with the Southern side of said alley, N. 85-39 W. 70 feet to an iron pin in line of lot 4; thence with the line of said lot, S. 1-41 W. 65 feet to a stake; thence S. 85-39 E. 70 feet to the beginning corner. Being the same property conveyed to the mortgagor by Adele Simpson Breazeale by deed to be recorded."
