# MORTGAGE

WE, CALVIN V. O'BRIENT and CLARICE N. O'BRIENT, of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

C. Douglas Wilson & Co.

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Ninety-eight Hundred and No/100-Dollars (\$ 9800.00 ), with interest from date at the rate of Four & one-fourth per centum ( 4 1/4 % ) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, S. All that certain lot of land with the improvements thereon situate on the West side of East Faris Road, in the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot 84 on plat of Forest Heights, made by Dalton & Neves, Engineers, June 1946, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "P", at page 71, said lot fronting 80 feet along the West side of East Faris Road, running back to a depth of 241.8 feet on the North side, to a depth of 195 feet on the South side and being 114 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
