We, J. W. Hillhouse & Laura D. Hillhouse

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eleven Thousand Eight Hundred and No/100- - - - DOLLARS (\$11,800.00), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the West side of Byrd Boulevard (formerly Ridge Street) in the City of Greenville, being the greater portion of lot 14 as shown on plat of property of L. A. Mills, made by R.E. Dalton in March 1925, recorded in Plat Book J at Page 29 and described as follows:

"BEGINNING at a stake on the West side of Byrd Boulevard, 78.65 feet North from Sirrine Drive, at corner of lot 13, and running thence along the line of lot conveyed to Annie T. Henderson, S. 67-47 W. 133 feet to an iron pin; thence N. 25-28 W. 72.6 feet to an iron pin; thence with the line of lot 15, N. 65-10 E. 135.6 feet to an iron pin on the West side of Byrd Boulevard; thence with the Western side of Byrd Boulevard, S. 23-26 E. 78.65 feet to the beginning corner."
