All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the north-west side of Sprague Street, near the City of Greenville, and designated in Lots 122, 121, and 120 of Block 22, Subdivision of Block 22, recorded in Deed Book 487, Page 231, and designated in Deed Book 510, Page 123, recorded in Deed Book 487, Page 231.

Block 22 is bounded on the north by the line of Lots 121, 122, and 123, and on the east by the line of Lots 121, 120, 119, 118, and 117, and on the south by the line of Lot 122, S. 41° 00' E. 200 feet to the east side of Johnson Street; thence with the Northwest side of Johnson Street, 200 feet to the beginning corner.
