To All Whom These Presents May Concern:

I, Robert McDaniel, of Greenville County, S. C., SEND GREETING:

Whereas I the said Robert McDaniel,  
in and by my certain promissory note in writing of even date with these  
Presents am well and truly indebted to John A. Park,

in the full and just sum of EIGHT HUNDRED and no/100 (\$800.00) DOLLARS,  
to be paid as follows: TWO HUNDRED and no/100 (\$200.00)  
DOLLARS on October 12, 1952, and a like amount on the 12th day of each  
and every succeeding October thereafter until paid in full; with the  
right to anticipate after One (1) year, by the payment of all or any  
part thereof at any time before maturity,

with interest thereon from date  
at the rate of 7 per centum per annum, to be computed and paid annually  
until paid in full: all interest not paid when due to bear

interest at same rate as principal: and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage: and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to  
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That I the said Robert McDaniel,  
in consideration of the said debt and  
sum of money aforesaid, and for the better securing the payment thereof to the said John A. Park,  
according to the terms of the said note, and also in  
consideration of the further sum of Three Dollars, to me the said Robert McDaniel,  
in hand well and truly paid by the said John A. Park,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained,  
sold and released, and by these Presents do grant, bargain, sell and release unto the said John A. Park,  
his heirs and assigns,

All that piece, parcel or tract of land in Butler Township,  
Greenville County, State of South Carolina, and containing Ten (10)  
acres, more or less, and bounded as follows: on the North by property  
of Lee Henderson; on the East by other property of Robert McDaniel; on  
the South by property of J. E. Watson; and on the West by Walter or  
Lizzie Griffith. The land has the following metes and bounds:

BEGINNING at an iron pin on paved county road running from  
Greenville to Pelham, corner of property sold to Lee Henderson, and  
running thence along line of Henderson property, S. 23-30 W. 104.5 feet to  
to iron pin on line of Walter Griffin property; thence with line of  
Griffin property, S. 27-10 E. 100 feet to iron pin, corner of property  
sold to J. E. Watson; thence along line of J. E. Watson property,  
N. 60-00 E. 1006 feet to iron pin; thence N. 49-58 W. 759.5 feet to the  
point of beginning, as shown by a plat made by Pickell And Pickell,  
Engineers, March 17, 1945.
