(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Six Thousand and No/100- - - - - DOLLARS (\$ 6000.00), with interest thereon from date at the rate of Five (5%) - - per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Eastern side of Summitt Drive, in the City of Greenville, and having the following metes and bounds, according to plat made by Dalton & Neves, Engrs., April 1951, recorded in Plat Book Z at Page 74 and described as follows:

"BEGINNING at iron pin on the Eastern side of Summitt Drive 530 feet North of the Northeast intersection of Northwood Avenue and Summitt Drive, and running thence along the Eastern side of Summitt Drive, N. 1-15 E. 100 feet to iron pin; thence S. 66-48 E. 242.9 feet to iron pin in line of property of Stone Estate; thence with line of Stone Estate, S. 23-22 E. 81 feet; thence N. 74-51 W. 266.2 feet to pin, point of beginning."
