SEND GREETING:

I, **W. E. Hughes**

Whereas, **I**, the said **W. E. Hughes**

in and by **my** certain **promissory** note in writing, of even date with these

Presents, **am** well and truly indebted to **G. P. Garrett**

in the full and just sum of **Two Thousand - - - - - Dollars**

, to be paid **on or by January 1, 1952**

, with interest thereon from **date**

at the rate of **6** per centum per annum, to be computed and paid **annually**

until paid in full: all interest not paid when due to bear

interest at same rate as principal: and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage: and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

sold and released, and by these Presents do grant, bargain, sell and release unto the said **G. P. Garrett**

**his Heirs and Assigns forever:**

All that piece, parcel or tract of land lying, being and situate in the County and State aforesaid, Austin Township, and on the Georgia Road, containing 54.85 acres, more or less, and bounded by lands now or formerly of R. L. Cooper, Mrs. Ethel Owings and others, designated as Tract No. 2 of the estate of Moses H. Cooper. Being the same tract of land this day conveyed to me by deed of the said **G. P. Garrett** to be recorded, reference to said deed being made for a better description as to lines, corners, distances, etc.

It is fully understood and agreed that this mortgage is junior in lien to a mortgage executed by me this day covering the within described premises to **B. C. Givens** in the principal amount of **\$2,000.00**, said mortgage to be recorded.
