TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Christine V. Camp

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifty-Five Hundred and No/100- - - DOLLARS (\$ 5500.00 ), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwestern side of Conestee Avenue, in the City of Greenville, being shown as lots Nos. 15, 16, and 17, on plat of North Cherokee Park, recorded in Plat Book A at Page 114, and is also shown as lot 9 on plat of Cherokee Park recorded in Plat Book "C" at Page 96, and being more particularly described as follows:

"BEGINNING at an iron pin on the Northwestern side of Conestee Avenue, at joint corner of lots 8 and 9 as shown on plat recorded in Plat Book "C" at Page 96, and running thence with the line of lot 8, N. 62-32 W. 168. feet 1 inch to iron pin on a 15 foot alley; thence with said alley, S. 27-58 W. 60 feet to pin at corner of lot 10; thence with line of lot 10, S. 62-32 E. 168 feet 6 inches to pin on Conestee Avenue; thence with the Northwestern side of Conestee Avenue, N. 27-11 E. 60 feet to the point of beginning. Said premises being the same conveyed to the mortgagor by Gertrude Abrams, et al by deed recorded in Volume 441 at Page 219."
