SEND GREETING:

Whereas, I, the said **Belton R. Coker**

in and by my certain **promisory** note in writing, of even date with these

Presents, **am** well and truly indebted to **The Pelzer-Williamston Bank**

in the full and just sum of **Five hundred - - - - - (\$500.00)-----**

-----Dollars, to be paid **on demand after date**

, with interest thereon from **date**

at the rate of **6** per centum per annum, to be computed and paid **semi-annually**

until paid in full: all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

sold and released, and by these Presents do grant, bargain, sell and release unto the said

The Pelzer-Williamston Bank, its successors and assigns forever;

All that piece, parcel or lot of land with improvements thereon, situated lying and being in **Oaklawn Township, County and State aforesaid**, and more fully described as follows:

BEGINNING at a point in center of the **Augusta road** at corner of land of **A. T. Traynham, Estate**, and running thence along line of said Traynham land **N. 56-30 W. 375.5 feet** to a stake; thence **N. 18-45 E. 120 feet** to a stake; thence **S. 50-30 E. 375.5 feet** to a point in the **Augusta Road**; thence along said road **S. 18-45 W. 120 feet** to the beginning corner, containing **One (1.00) acre**, more or less; this being that same lot of land conveyed to me by **J. A. Coker** by his deed dated **March 19, 1936**, recorded in **R. M. C. Office for Greenville County, State of South Carolina**, in **Vol. 188** at page **25**.

ALSO ALL THAT OTHER piece, parcel or lot of land in **Oaklawn Township, Greenville County, State of South Carolina**, on the **East side** of the **Augusta Road**, being known and designated as **Lot No. 2** on plat and survey of property of **W. M. Boyce, Estate**, said plat prepared by **W. J. Riddle**, **May 26, 1943**, and recorded in said **R. M. C. Office** in **Plat Book N.** at page **143**, and being described by said plat as follows;
